GUIDE TO SPEAKERS

Ronald Asmus

Senior Transatlantic Fellow, German Marshall Fund

Dr. Asmus also serves as senior advisor to GMF on a number of strategic and developmental issues. He was Deputy Assistant Secretary for European Affairs in the Clinton Administration. Previously a Senior Fellow at the Council on Foreign Relations, RAND, and Radio Free Europe, he is currently an Adjunct Senior Fellow at the Council on Foreign Relations in Washington, D.C. Dr. Asmus is the holder of the U.S. Department of State's Distinguished Honor Award; the Republic of Poland's Commander's Cross, Order of Merit; the Republic of Lithuania's Order of the Grand Duke Gediminas (Second Class); and the Republic of Estonia's Order of the Cross of St. Mary's Land (Third Class). He is a member of the Board of the Committee on NATO and the U.S. Baltic Foundation. Dr. Asmus has written widely on European security issues in journals and newspapers on both sides of the Atlantic.

Jonathan Davidson

Senior Adviser, Political/Academic Affairs, European Commission Delegation; Adjunct Professor, John Hopkins University and The American University

Mr. Davidson serves as liaison between the White House, the Department of State, other Federal Government agencies, and the non-governmental foreign policy community. In addition, he reports to the European Commission on foreign policy and security developments, focusing on the Balkans and the Middle East. He also serves as liaison with U.S. universities, managing a support program for teaching European Union affairs, including the new network of EU Centers. He has organized international video conferences on European Union affairs and EU-US relations. Mr. Davidson was Director of the University of South Carolina's Washington office from 1981-91, and, at the same time, was Special Assistant for International Programs to the USC President; and Visiting Professor. From 1963-81, he served in the British Diplomatic Service in England, India, Thailand, Senegal and the U.S. At the British Embassy in Washington he was responsible for congressional liaison and U.S. political relations (1975-79) and was head of information and press relations (1979-81). Publications include The European Community in the Nineties (editor;1992); One Market, Many Openings: Europe Unifies its Economy (1994); The European Union: A Guide (editor; 1994, revised 1999). He holds an M.A. in history from Cambridge University, U.K.

Daniel Hamilton

Research Professor/Director, Center for Transatlantic Relations, the Paul H. Nitze School of Advanced International Studies (SAIS), John Hopkins University and Executive Director, American Consortium on EU Studies

Dr. Hamilton most recently served as Deputy Assistant Secretary of State for European Affairs. He was also U.S. Special Coordinator for Northern Europe; U.S. Special Coordinator for Southeast European Stabilization; Associate Director of the Policy Planning Staff for Secretaries of State Madeleine Albright and Warren Christopher, Policy Advisor to Assistant Secretary of State for European Affairs Richard Holbrooke; and Senior Policy Advisor to Ambassador Holbrooke and the U.S. Embassy in Germany. Previous to his government service, Dr. Hamilton was Senior Associate on European-American relations at the Carnegie Endowment for International Peace. Dr. Hamilton has a Ph.D. and an M.A. from the John Hopkins School of Advanced International Studies and received his B.S.F.S. from Georgetown University's School of Foreign Service. He is a member, Board of the Korber Foundation's USABLE awards program and has served for more than two decades as Dean of Waldesee, North America's premier German language immersion program for young Americans. He is the author of Beyond Berlin: America and the Berlin Republic (1994), After the Revolution (1990), and articles in a variety of books and publications such as Foreign Policy, Los Angeles Times, Washington Quarterly, and Japan Times. He has been awarded Germany's Federal Order of Merit and holds the State Department's Superior Honor Award.

Charles A. Kupchan

Senior Fellow and Director, Europe Studies at the Council on Foreign Relations; and Associate Professor of International Relations, School of Foreign Service and Government, Georgetown University

Dr. Kupchan was Director for Europe Affairs on the National Security Council during the first Clinton Administration. Before joining the NSC, he worked in the U.S. Department of State on the Policy Planning Staff. Prior to government service, he was an Assistant Professor of Politics at Princeton University. He is the author of *The End of the American Era* (2002) as well as numerous other books and articles on international and strategic affairs. Dr. Kupchan received a B.A. from Harvard University and M.Phil. and D.Phil. degrees from Oxford University. He has served as visiting scholar at Harvard University's Center for International Affairs, Columbia University's Institute for War and Peace Studies, the International Institute for Strategic Studies in London, and the Centre d' Etudes et de Recherches Internationales in Paris.

Rolf Nikel

Minister for Political Affairs, German Embassy

Prior to his current position, Mr. Nikel served as a Fellow of the Weatherhead Center for International Affairs at Harvard University. He was also the Deputy Director and later the Director for Eastern European Affairs in Bonn and Deputy Head of the Political Section of the German Embassy in Paris. In addition, he has been the First Secretary for International Matters and for the Relations with the United Nations' Environment Program and the UN Program for Human Settlements (HABITAT) at the German Embassy in Nairobi as well as Second Secretary for the Cultural Attaché at the German Embassy in Moscow. Mr. Nikel has studied at Goethe Frankfurt University, Duke University, and Harvard University and holds a diploma (with honors) from the Institut d'Etudes Politiques, Paris.

Catherine Novelli

Assistant U.S. Trade Representative for Europe and the Mediterranean, Office of the U.S. Trade Representative

In her current position, Ms. Novelli is responsible for coordinating U.S. trade policy for Western Europe, Central Europe, the Newly Independent States of the former Soviet Union, the Middle East and Northern Africa. She developed and continues to manage the Transatlantic Economic Partnership (TEP). She also co-chairs the Russia Economic Policy Group and has developed and chairs the Trade and Investment Framework Agreement (TIFA) Councils with countries in the Middle East and North Africa. Prior to assuming her current position, Ms. Novelli was the Deputy Assistant U.S. Trade Representative for Central and Eastern Europe and Eurasia. She also served in the Office of the General Counsel at the U.S. Department of Commerce. She holds a L.L.M. in international law from the University of London and a J.D. from the University of Michigan Law School. Her B.A. is from Tufts University.

John Van Oudenaren

Chief, The European Division of the Library of Congress

Adjunct Professor, BMW Center for German and European Studies, Georgetown University

Prior to joining the Library of Congress, Dr. Van Oudenaren was a senior researcher at the RAND Corporation. From 1991-95 he served as the director of RAND's European office in Delft, the Netherlands. He has served on the Policy Planning Staff of the U.S. Department of State and has been a research associate at the Kennan Institute for Advanced Russian Studies, Woodrow Wilson International Center for Scholars, Washington, D.C., and at the International Institute for Strategic Studies in London. He has a Ph.D. in Political Science from the Massachusetts Institute of Technology and an A.B. in Germanic Languages and Literature from Princeton. His has published numerous books, articles, chapters, and reports on Europe, Russia, and U.S. foreign policy.

Charles P. Ries

Principal Deputy Assistant Secretary of State European and Eurasian Affairs

Prior to his appointment, Mr. Ries was Minister Counselor for Economic Affairs at the U.S. Embassy in London and Minister Counselor for Economic Affairs at the U.S. Mission to the European Union. From 1990-92 he was detailed to the Office of the U.S. Trade Representative as Deputy Assistant U.S. Trade Representative for North American Affairs and a member of the North American Free Trade Agreement (NAFTA) negotiating team. Since joining the Foreign Service in 1977, he has also served as a special assistant and executive assistant to the Under Secretary of State for Economic Affairs, in the Energy Policy Office and the Office of the Counselor, and at the U.S. Embassies in Ankara and Santa Domingo.

Joanne van Selm

Senior Researcher, University of Amsterdam's Institute of Ethnic and Migration Studies

Dr. van Selm focuses on refugee protection and international humanitarian response and migration management. She co-edits the *Journal of Refugee Studies* and is President of the International Association for the Study of Forced Migration, for which she developed and chaired the program of the 7th bi-annual conference in January 2001. She also codirected a project on Security and Refugees for the United Nations University in 2000-2001. Dr. van Selm has published widely on temporary protection, European asylum policy, and other refugee and migration-related topics. Dr. van Selm holds an M.A. and Ph.D. in International Relations from the University of Kent at Canterbury, UK.

Simon Serfaty

Director, Europe Program, Center for Strategic and International Studies (CIES); Senior Professor of U.S. foreign policy, Graduate Program in International Studies, Old Dominion University

From 1972-93, he was a Research Professor at the Johns Hopkins School of Advanced International Studies (SAIS) in Washington, D.C., serving as director of the Johns Hopkins Center of European Studies in Bologna, Italy (1972-76), director of the Washington Center of Foreign Policy Research (1978-80), and as executive director of the Johns Hopkins Foreign Policy Institute (1984-91). Among books Dr. Serfaty has authored are La tentation impériale (2004), Memories of Europe's Future(1999), Stay the Course (1997), and Taking Europe Seriously (1992). Forthcoming is Power and Order: The Imperial Temptation and its European Dimension (2004). Books edited by Dr. Serfaty include Visions of America and Europe: September 11, Iraq and Transatlantic Relations (2004), The European Finality Debate and its National Dimensions (2003) and The Media and Foreign Policy (1990). Dr. Serfaty's articles have appeared in most leading professional journals in the U.S. and Europe, and he has been a guest lecturer in over 40 different countries. Dr. Serfaty holds a Ph.D. in Political Science from the Johns Hopkins University. In 2001, Old Dominion University designated him as Eminent Scholar of the University, and in 2003, he was named the first holder of the Zbigniew Brzezinski Chair in Global Security and Geostrategy at CSIS.

Michael Wyganowski

Counselor-Head of the Political Section, Embassy of the Republic of Poland Mr. Wyganowski follows and reports on security issues, transatlantic relations, terrorism, homeland security, arms control, nonproliferation, and military-to-military cooperation. Previously, he served as the Coordinator for the Implementation of the Disarmament Agreements, as First Secretary of the Polish Embassy, as Counselor at the Ministry of Foreign Affairs and as Assistant to the Director General at the Council of Ministers. A specialist on foreign policy, security, and U.S. European relations, he has lectured at various universities, including George Washington University, American University, Georgetown University, the University of Georgia, National Defense University and Columbia University on foreign policy, security, and U.S.-European relations. With a Master of Arts in History from Warsaw University, he has completed post graduate studies in diplomacy at the Polish Institute of International Relations as well as the Diplomat Training Program in intensive studies in economics and international trade at the Hoover Institute, Stanford University.
