GUIDE TO SPEAKERS

David G. Brown (B.A., Princeton University)

Director, Office of Regional and Security Policy Bureau of East Asian and Pacific Affairs, U.S. Department of State.

Mr. Brown has been a member of the Foreign Service of the United States for over 25 years having served in Taipei, Saigon, Tokyo, Vienna, Beijing, Oslo, Washington, and Hong Kong. His assignments include: Economic Counselor in Beijing, Political Counselor and then Deputy Chief of Mission in Oslo, Director of the State Department's Taiwan Coordination Staff, Deputy Consul General in Hong Kong, and Director of the Office of Indonesia, Malaysia, Brunei and Singapore Affairs in the Bureau of East Asian and Pacific Affairs.

Peter A. Cashman (B.A., Catholic University)

Acting Deputy Assistant Secretary for East Asia and the Pacific, International Trade Administration, U.S. Department of Commerce.

Mr. Cashman has had a long career in the U.S. Department of Labor, the U.S. Department of State and, the U.S. Department of Commerce. He has held numerous positions in the International Trade Administration including most recently Director of the Office of the Pacific Basin and Acting Deputy Assistant Secretary of the Foreign Commercial Service.

Peter M. Cleveland (B.A., Columbia University)

Staff Member, Subcommittee on East Asian and Pacific Affairs of the U.S. Senate Foreign Relations Committee.

Mr. Cleveland's current responsibilities include organizing the Subcommittee's hearings, keeping its members and chairman informed of developments in the Asia/Pacific region and U.S. foreign policy decisions relevant to the region. Previously he was Legislative Assistant for Foreign Affairs, International Trade and Intelligence for U.S. Senator Charles S. Robb.

Brigadier General John B. Hall, Jr. (B.A., (Business Administration) Univ. of Massachusetts; M.A., (Public Administration) Golden Gate University)

Director, East Asia Pacific Region in the Office of the Assistant Secretary of Defense for International Security Affairs.

A career officer in the United States Air Force, General Hall has commanded four Air Force wings in West Germany, Japan, and Saudi Arabia. He has received numerous awards from the U.S. Air Force including the Legion of Merit and Distinguished Flying Cross and from the Republic of Vietnam. General Hall also was a senior research fellow at the Rand Corporation.

Seung-Soo Han (D.Phil., (Economics) University of York)

Ambassador of the Republic of Korea to the United States.

Prior to his current appointment in 1993, Ambassador Han held distinguished posts in government and academia. He served as Minister of Trade and Industry and as a ruling party member of the National Assembly. Previously Ambassador Han had a long career in academia as Professor of Economics at Seoul National University and Director of the Institute of Social Sciences, and as a Fulbright Senior Scholar at Harvard University. Ambassador Han has published numerous books on taxation, economic growth, and finance. His many honors include awards from Belgium, Taiwan as well as the Republic of Korea. Ambassador Han was appointed the first Chairman of the Korea Trade Commission and served as a member of the Commission of Tariff Reform, as well as advisor to several public and private sector organizations including the Bank of Korea, the Korea Chamber of Commerce, the Korean Foreign Trade Association, and as consultant to the World Bank and UNESCAP.

Selig S. Harrison (B.A., Harvard University)

Senior Associate of the Carnegie Endowment for International Peace.

A former Washington Post foreign correspondent and author of five books on U.S. relations with Asia, Mr. Harrison has covered a broad range of Asian countries for 35 years. Mr. Harrison is widely respected for his independent approach to controversial issues and his ability to predict significant developments. He is frequently invited to testify as an expert witness before Congressional committees and to lecture at the National Defense University, the National War College and the State Department's Foreign Service Institute. At the same time, Mr. Harrison's outspoken criticism of Administrative policies in many countries often appears on the Op-Ed pages of The Washington Post, The New York Times and The International Herald-Tribune. He has appeared on the MacNeil-Lehrer Report, "Night Line" and other TV programs as well as National Public Radio's "All Things Considered" and "Morning Edition."

Donald W. Keyser (B.A., (Political Science/Russian Area Studies), University of Maryland; M.A., George Washington University/Sino-Soviet Institute)

Director, Office of Chinese and Mongolian Affairs (EAP/CM), U.S. Department of State.

Mr. Keyser is a career Foreign Service Officer specializing in China and Japan since joining the State Department in 1972. He has served three times in Beijing, most recently as Minister-Counselor for Political Affairs. Mr. Keyser also served twice in Japan, most recently as Chief of the Political/External Unit. During 1992-1993 he chaired two interagency panels and drafted reports on U.S. policy toward Japan.

Takakazu Kuriyama (D. Phil., (Honorary) Lawrence University)

Ambassador Extraordinary and Plenipotentiary of Japan to the United States

Ambassador Kuriyama has had a long and distinguished career in the Ministry of Foreign Affairs and numerous diplomatic posts. His appointments with the Ministry include Director-General of the North American Affairs Bureau, Director-General of the Treaties Bureau, Deputy Minister for Foreign Affairs, Vice Minister for Foreign Affairs, and Advisor to the Minister for Foreign Affairs. He has also served as Ambassador Extraordinary and Plenipotentiary of Japan to Malaysia.

Cheryl McQueen (B.A., (Economics) Radcliffe College; M.P.A., Princeton University's Woodrow Wilson School for International Affairs)

Senior Desk Officer, Office of China, Hong Kong, and Mongolia, U.S. Department of Commerce.

As Senior Desk Officer, Ms. McQueen is responsible for the development of policy and program recommendations on a number of trade, investment and commercial policy issues concerning China. Her specific areas of responsibility include U.S. participation in China's service sectors, liaison with U.S. and international donor agencies, and China's accession to the GATT. Ms. McQueen previously served as desk officer in the Office of South Asia and the Office of the Near East.

John P. Nixon (B.A., (Political Science) Boston College; M.A., (Asian Studies) American University)

Defense Intelligence Officer for East Asia and Pacific, Defense Intelligence Agency.

Prior to his current appointment, Mr. Nixon, was the Senior Analyst for the China/Japan Branch of the Directorate for Intelligence. He has also served as the China Desk Officer for International Security Affairs, Intelligence Estimator for Chinese Political Military Affairs and Strategic Forces, and Intelligence Analyst for Asia Pacific, a Special Actions Branch for the Directorate for Production.

Jiechi Yang

Minister and Deputy Chief of Mission, Embassy of the People's Republic of China to the United States.

Prior to his current appointment in 1993, Minister Jiechi served as the Deputy Director of the American and Oceanian Affairs Department in the Chinese Foreign Ministry. He also has served as Counselor and Division Chief of the Translation and Interpretation Department in the Chinese Foreign Ministry and as Second, First Secretary, and Counselor in the Embassy of the People's Republic of China in the United States.

Marjory E. Searing (B.A., SUNY-Binghamton; M.A. and Ph. D. (Economics) Georgetown University).

Deputy Assistant Secretary for Japan, U.S. Dept. of Commerce.

Appointed in 1990 as the deputy assistant secretary for Japan in the International Trade Administration, Dr. Searing is the principal adviser on the U.S. trade relationship with Japan. She directs the development of economic, commercial and trade policy, and of programs related to Japan. Her office also analyzes Japanese economic and political developments. In 1986, Dr. Searing was appointed Director of the Office of Multilateral Affairs, where she was responsible for managing the department's participation in multilateral trade negotiations. Previously she served as acting deputy assistant secretary for science and electronics, Director of the Office of Industrial Assessment for the International Trade Administration, and Director of the Office of International Sector Policy.

Russell J. Wilson (A.B., (Political Science) Columbia University; M.A., (National Security Studies) Georgetown University).

Staff Director, Subcommittee on Asian and Pacific Affairs, and U.S. House of Representatives, Committee on Foreign Affairs.

Mr. Wilson is responsible for coordinating all work of the subcommittee. He is principal political and economic policy advisor to Members of Congress on issues involving Asia and the Pacific Rim nations, and foreign policy advisor to the subcommittee chairman on regional and functional foreign policy issues. Mr. Russell was a member of the first team in history to cross the demilitarized zone separating North and South Korea, October 12, 1993. Previously he was the principal foreign policy advisor to Republican Members of the House Subcommittee on East and West Europe, the former Soviet Union, and the Middle East.
